# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to http://mictlantarot.com/, and Mictlan Tarot LLC and governs data collection and usage. ## **Collection of your Personal Information**

In order to better provide you with products and services offered, Mic may collect personally identifiable information, such as your:

If you purchase Mic's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is

compatible with the context in which you provided the information.
